Work Profiled in Mid-Ohio Foodbank's Newsletter

Previous undergraduate research assistant with SRI, Sarah Lenkay, who graduated in 2010 from SENR, is completing her first year of service with the AmeriCorps VISTA program at the Mid-Ohio Foodbank. The work she is doing was recently highlighted in their newsletter. As the Produce Market Coordinator and Community Garden VISTA, Sarah splits her time about 80-20 with Mid-Ohio Foodbank and as the coordinator for the Franklin County Commissioners' Gantz Road Community Garden. At the Foodbank, Sarah is responsible for their produce initiatives. She has facilitated an initiative to distribute 6 million pounds of fresh food to high-need areas within a 4 month time period. They accomplish this primarily through Produce Markets, with 150 markets total in 20 counties. Their trucks go to agency partners and give away the produce free of charge to those who are in need of assistance. Next vear. Sarah will continue to work with the Mid-Ohio Foodbank as their Community Garden Coordinator VISTA to develop a comprehensive youth garden and life skill program. With OSU Extension, Franklin Park Conservatory, and other partners, she will be fusing gardening, food preparation and cooking, budgeting, and nutrition into a program for urban youth that can be replicated. \(\psi\)

Final Master's Fellow Completes Fellowship Training Program with a thesis focused on food entrepreneurs

Erin Caricofe's thesis, "Handcrafting The Change They Want To Eat In The World? An Inquiry Into The Who, What, and Why of Artisanal Food Production in Central Ohio" offers a qualitative portrait of artisanal food producers and the various factors motivating them. While artisanal food production is occurring nationally, this research focuses on the motivations and factors influence.

ing a set of Central Ohio food artisans, to explore some of the following questions: What does it mean to be artisanal? What are the artisans' core values and motivations? How are food artisans' participants in what academics refer to as the "quality turn?" Where do food artisans stand in opposition to mass-produced, industrial

food? Are food artisans a new part of the alternative food movement, or a movement unto themselves? In what ways does their work impact the dominant food system? Data revealed food artisans to be values-based individuals emphasizing product quality through their careful sourcing of ingredients (mostly local) and the use of traditional, time-consuming production methods. The food artisans studied expressed a strong desire to operate as locally embedded businesses, consistent with the ideas of Civic Agriculture. Their production practices and product quality goals reveal an alignment with the quality turn occurring in the food system, and a broadening of what the quality turn can encompass. While these artisans were not actively involved in an alternative food system movement as identified by other food system scholars, there were many similarities in terms of personal motivations and business practices among these artisans. Future studies in other regions and of larger samples of artisans might investigate the extent to which these artisans represent their own food system movement. Erin will be returning to Washington, DC to continue working with the food and agriculture community. We wish her much success!
